





4. Bidders who wish to participate in online tenders may be preferred if they have legally valid Digital Signature and Encryption as per Information Technology Act, 2000, using which they can/ may sign their electronic bids.
5. No physical submission of price/financial bid will be entertained as it should be furnished on-line only. Also, no fax, email, SMS, letters or any other form of communication will be entertained for the same.
6. Before electronically submitting the tenders, it should be ensured that all the tender papers are digitally signed by the Bidder.
7. Any attempt to submit Financial bid through mode other than online will result in cancellation of bid and forfeiture of EMD of the bidder concerned.
8. Earnest money deposit in respect to tender may be submitted by way of DD/Bankers' Cheque payments within the specified dates, time and place as mentioned in the tender document. Scanned copy of the DD/Bankers' Cheque payments should be uploaded along with the online Technical Bid.

ELIGIBILITY CONDITIONS

- a. The tenderer should be an Income Tax Assessee. In support of this, attested copy of Permanent Account Number (PAN) and latest Income Tax returns are required to be submitted.
- b. Manufactures/ firms/ authorized dealers, should not have been blacklisted or debarred for any default by any Govt. Dept./Organization. If any of the Member has been blacklisted, he shall be excluded from the participation in the tender. An affidavit as per Annexure-V duly attested by the Oath Commissioner/Notary is required to be submitted in support thereof.
- c. The firms shall necessarily registered with National Small Industries Corporation (NSIC) and MSME, have to enclose valid self-attested Registration Certificate(s) along with the tender to this effect. The requirement of Earnest Money will be validated as per the rules.

TERMS AND CONDITIONS

1. GENERAL

- a) Tenders should be filled duly furnishing the required information as per Tender document.
- b) Tenders should be strictly in conformity with the prescribed terms and conditions. Tenders should not contain any conditions other than the prescribed. Tenderer, who deviate from these terms and conditions, are liable to be rejected.
- c) The concerned authority will conduct a pre-bid meeting on 08.01.2024, and any amendments required consequent on the pre-bid meeting, the same will be intimated on or after 08.01.2024.
- d) The BCKV has the right to amend any of the tender conditions, as may be desired. If such an amendment is absolutely necessary, the same shall be communicated to the Tenderer which shall be made available on websites till before the last date of receipt of tender.
- e) Tenderer should be capable of completing the supply, erection & commissioning of the ordered items within 60 days from the date of acceptance of offer.
- f) The Registered Companies/ Manufacturer/Firms/Authorized Dealers who are blacklisted by the Government/State Agency/any firm are not entitled to file/participate in the tenders. The Tenderers have to submit an affidavit in the prescribed proforma (Annexure-V) that they are not blacklisted by the Government/ State Agency. If the blacklisted firm, etc., file tender in benami name, the same shall be stand rejected apart from forfeiture of EMD furnished.
- g) Minors/insane are not eligible to file tenders.
- h) Tender Form is not transferable. Tenderer should sign on all pages of the Tender Form.
- i) A bidder may withdraw, substitute or modify its bid after it has been submitted in accordance with the online procedure of bid (i.e) e-procurement.
- j) No bid shall be withdrawn, substituted or modified after the last time and date fixed for receipt of bids as prescribed in <https://www.bckv.edu.in/index.php/en/tenders-en>.
- k) Validity of bid offer is up to 180 days.
- l) All the disputes and differences arising out of or in any way touching or concerning this agreement whatsoever (except as to any matter the decision of which is expressly provided for in the contract) shall be referred to the sole arbitration of the BCKV. In case the arbitrator to whom the matter is originally referred is transferred or vacates

office or is unable to act for any reason whatsoever, the BCKV shall be competent to appoint another person as Arbitrator. There will be no objection that the person so appointed is or was in the employment of the BCKV/ administration of the Government of West Bengal and as an employee of the BCKV had during the course of his duties expressed views on all or any of the matter of difference or dispute. The award of such arbitration shall be final and binding on the parties to this contract. The Courts of West Bengal only will have the jurisdiction in the matter of arbitration.

m) The BCKV reserves the right to relax/cancel any of the provisions contained herein above.


2. EARNEST MONEY DEPOSIT & TENDER FEE

Technical bid should be accompanied with EMD amount Rs. **50,000/-** (Rupees Fifty Thousand only) by way of an Account Payee Demand Draft/Bankers' Cheque drawn on any Nationalized/ Scheduled Bank in favour of the "Bidhan Chandra Krishi Viswavidyalaya", payable at SBI Kalyani.
