**Price:** The price of the equipment should be quoted in INR and net per unit (including taxes and duties etc.) However, university will provide valid DSIR and authorization certificate to the clearing, if required. Quotation must include all necessary accessories as mentioned for the items) from reputed company. Without necessary accessories the tender will be considered incomplete. Quoted rate must be for destination including packing, installation and delivery charges up to the laboratory at Crop Research Unit (Genetics and Plant Breeding), Bidhan Chandra Krishi Viswavidyalaya, Mohanpur, Nadia PIN 741252 with satisfactory installation and demonstration. Payment will be processed only on receipt bill, challan and other required documents after satisfactory installation and demonstration of the system.
