3. The entire cost of the above ponds as would be offered by the party and duly accepted by the authority will have to be paid to the In-Charge RRS Kakdwip Farm, BCKV against demand draft or cash, with in 7 days from the date of acceptance of the tender.
4. A photocopy of Identity card with photograph, such as Aadhaar, EPIC, Driving license, passport etc must be enclosed with tender.
5. The authority may take water from the said pond or may use the water of pond at any time, if need.
6. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
7. Immediately after completion of cultivation of fish from the ponds, the selected bidder has to hand over the ponds to the authority, otherwise his/her refundable security deposit will be forfeited and/or authority can take appropriate action.
8. The decision of the authority in any case is final.
