3. The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the **"Aadhaar Card"** folder while applying online (in .pdf format).
4. The Applicant has to upload scanned copy of self attested photocopy of his/her PAN Card in the **"PAN Card"** folder while applying online (in .pdf format).

24. The selected bidder has to maintain close contact with the Farm In-Charge, Balindi R. Complex, BCKV during the entire period.

31. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
32. The authority may take water from the said pond or may use the water of pond at any time, if need.
33. The decision of the authority in any case is final.

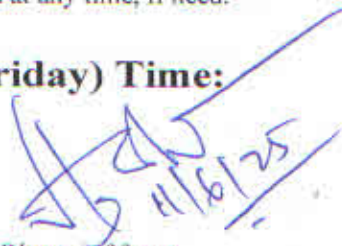
