The tender in sealed cover is hereby invited from bonafide parties for disposal of Non seed items at DSF AB Block Farm, BCKV.

#### DSF AB Block Farm, BCKV

1. Non seed Wheat	-	1320 kg. (approx)	- Minimum rate for this item Rs. 23 /- per Kg.
2. Cheek pea	-	200 kg. (approx)	- Minimum rate for this item Rs. 30/- per Kg.
3. Ground Nut	-	209 kg. (approx)	- Minimum rate for this item Rs. 35 /- per Kg.

Intending parties may see the above mentioned Non Seed items in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm In-charge.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate must be ex-godown and without any container.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & Mobile No. & photo copy of photo ID proof.

The entire cost of the above Non Seed items as would be offered by the party and duly accepted by the authority will have to be paid to the concerned In-charge against demand draft or cash, within 7 days from the date of acceptance of the tender. Otherwise his "Earnest Money / Security deposit will be forfeited.
