NOTICE

All students are hereby informed that, in the interest of maintaining discipline and ensuring the safety, security, and well-being of all residents, the movement of students within the University campus and hostel premises shall be regulated as per the following instructions:

1. Restriction during Class Hours:

- Students are prohibited from leaving the University campus during class hours.
- ❖ Students must ensure a minimum of 75% attendance to be eligible to appear in examinations, as mandated by the rules of the Viswavidyalaya.
- ❖ Non-compliance with attendance requirements or unauthorized absence from the campus during class hours may attract **disciplinary proceedings** as per University regulations.

2. Restriction during Night Hours:

❖ Movement of students outside the campus is strictly prohibited during restricted night hours, i.e., from 10:30 PM to 4:30 AM.

3. Exceptions to the Restriction:

Leaving the campus during the restricted hours shall be permitted only under the following circumstances:

- ❖ In case of a genuine medical emergency, or
- * With prior written permission from the competent authority, such as the Dean, Students' Welfare, BCKV; Security Officer, BCKV; or any other authorized officer.

4. Procedure for Permission:

- Students who are required to leave the campus due to unavoidable reasons must obtain written permission in advance.
- ❖ Such permission must be **submitted to the Security Office before exiting** the campus.

5. Disciplinary Action:

❖ Any student found violating the above instructions shall be liable to **strict disciplinary action** in accordance with the rules and regulations of the College/University.

These measures are instituted solely in the interest of student safety, academic discipline, and uninterrupted learning.
