The entire cost of the above animal as would be offered by the party and duly accepted by the authority will have to be paid to the concerned In-charge against **cash or online transfer ( PNB bank A/C no. - 0759010158664, IFSC No. - PUNB0075920 )** within 10 days or earlier from the date of acceptance of the tender otherwise his " Earnest Money / Security deposit will be forfeited.
5. **The Draft must be drawn by the bidder with his own name or name of the proprietor.**
6. **The date of the Draft must be in between issuing date of tender to last date of submission of quotation of said tender, otherwise the quotation would be deemed as cancelled.**
